<b>APR for Cash Advances</b>	<p><b>13.99% to 21.99%</b></p> <p>This APR is based on your creditworthiness and will vary with the market based on the Prime Rate.</p>
<b>Penalty APR and When It Applies</b>	<p><b>25.00%</b> This APR may be applied to your account if you make a late payment</p> <p><b>How Long Will the Penalty APR Apply?</b> If your APR is increased for this reason, the Penalty APR will apply until you make six consecutive minimum payments when due.</p>
<b>Paying interest</b>	Your due date is at least 25 days after the close of each billing cycle. We will not charge you any interest on purchases if you pay your entire balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the transaction date.
<b>Minimum Interest Charge</b>	If you are charged interest, the charge will be no less than <b>\$1.50</b> .

<b>Penalty Fees</b>	<ul style="list-style-type: none"> <li>• Late Payment Fees: Up to <b>\$35.00</b></li> <li>• Over-the-Credit Limit: Up to <b>\$30.00</b></li> <li>• Returned Payment: Up to <b>\$32.00</b></li> </ul>

**How We Will Calculate Your Balance:** We use a method called “average daily balance (including new purchases).” See your account agreement for more details.

**Variable Rate Information:** Your APR may vary. Rates are determined and adjusted monthly on the third business day by adding a Margin to the highest Prime Rate published in the Wall Street Journal on the first day of the previous month. The Margin is based on evaluation of each Cardholder’s credit history. The margin will range from 8.49% to 16.49%.

**Billing Rights:** Information on your rights to dispute transactions and how to exercise those rights is provided in your account agreement.
