Annual Percentage Rate (APR) for Purchases	10.75% to 13.75% This APR is based on your creditworthiness and will vary with the market based on the Prime Rate.
APR for Balance Transfers	10.75% to 13.75% This APR is based on your creditworthiness and will vary with the market based on the Prime Rate.
APR for Cash Advances	10.75% to 13.75% This APR is based on your creditworthiness and will vary with the market based on the Prime Rate.

The Margin is based on evaluation of each Cardholder’s credit history. The margin will range from 4% to 7%.
